Zorabots becomes TaleMate.

Zorabots entities form TaleMate, a new high-tech company focussed on software.

Robotics company Zorabots and its affiliated entities are transforming into TaleMate, a brand-new corporation focussed on high-tech software. TaleMate is founded by the current Zorabots CEOs Tommy Deblieck and Fabrice Goffin and investor Bart Versluys, with a registered capital of 30.4 million euro. The co-CEOs remain in charge, but TaleMate shifts the focus from robotics to high-tech software guiding and connecting IoT, metaverse and robotics. “After extensive R&D we created a no-code software platform with capabilities far beyond robotics”, the CEOs explain. “The connection with IoT-devices and the virtual world signifies a huge step forward, a step that we are taking in a new environment with new investors on board.”

Ostend, 05/09/2023 – In recent years, Zorabots has transformed from a company focussed on the complete process of employing robots to an innovative software company. “From now on, TaleMate will focus solely on the development of its software and will no longer be active in the field of robotics hardware. This shift requires the newly created environment”, say Deblieck and Goffin. “With an increase in capital to 30,4-million-euro, TaleMate takes the next step in developing its innovating software platform, implement the signed contracts, and sign several new contracts.” In addition to the investment of Bart Versluys and Scorpiaux worth 50%, TaleMate will attract other investors to further strengthen the company. “The new capital will allow for the development of the software platform to its full potential and ensures the continuation of the current growth.”

The decision to develop the software platform to link robotics with IoT and metaverse and connect these three components has proven particularly valuable. The software’s ability to control and link over 2.000 brands of smart devices, combined with its no-code system, due to which no programming knowledge is required to operate the software, makes it a high-tech platform unique in

the world. “The contracts with QSS in Saudi Arabia and Arco in Canada have confirmed this claim and the value of the software. They were a game-changer for the company, boosting the evolution of the software and the business development. TaleMate will adopt these contracts in their entirety and will continue working following the chosen path” Goffin and Deblieck conclude.

About TaleMate: *TaleMate is the new corporation formed by the various entities of Zorabots. Zorabots itself was founded as an Ostend based company in 2011 by co-CEO’s Tommy Deblieck and Fabrice Goffin. The focus was on developing and controlling robotics, but after extensive R&D shifted towards high-tech software. This evolution resulted in the development of the smart-software platform ZBOS aimed at controlling and linking robotics, IoT and metaverse. With ZBOS TaleMate develops tailor-made solutions for companies to control, link and automate various high-tech processes.
